It states that if a landowner had received sunlight across adjoining property for a particular period of time, that landowner was entitled to continue to receive unobstructed access to sunlight across the adjoining property. According to this doctrine, the landowner acquired a prescriptive easement and could not be prevented from access to light.

claimant's land without any written consent from the owner of the land over which the easement is claimed.

Ancient lights, in English property law, the right of a building or house owner to the light received from and through his windows. Windows used for light by an owner for 20 years or more could not be obstructed by the erection of an edifice or by any other act by an adjacent landowner. This rule of law originated in England in 1663, based on the theory that a landowner acquired an easement to the light by virtue of his use of the windows for that purpose for the statutory length of time.
